3. The College will be offering Four-Year Undergraduate Programmes at the UG level and to begin with will offer Two-Year Postgraduate Programmes (M.Com.) till the academic year 2026-2027.
4. The College has decided to opt for Department Specific Core (DSC) for Major courses.
5. 1 credit will be equal to 15 hours of teaching.
6. The duration of each lecture will be of 60 minutes.
7. The workload of an assistant professor will be 16 lectures per week.
8. 1 credit= 25 marks of evaluation.

The I/c Principal also highlighted the following important implications of the NEP-2020 and Autonomy:

1. More UG and PG programmes to be introduced in near future.
2. Number of subjects have increased and will continue to increase in future.
3. Extra-curricular activities have been mainstreamed.
4. Multiple entry and multiple exit
5. Students have a greater choice in selecting subjects.
6. Basket of electives which are inter-disciplinary in nature.
7. Emphasis on on-job training and research.
8. Students will be spending longer hours on the campus.
9. More number of examinations.
10. The Degree College is now a mini university.

### b) Library and Academic Audit

The recommendations made by experts as part of the Library Audit (for A.Y. 2021-2022 and A.Y. 2022-2023) and Academic Audit (for A.Y. 2022-2023) were placed before the Members. The recommendations and the actions to be taken were discussed.

### c) Admissions to the First Year UG and PG Programmes for the A.Y. 2023-2024

The admissions to the First Year UG and PG Programmes for the A.Y. 2023-2024 have been almost completed. The I/c Principal informed the members that for the current academic year A.Y. 2023-2024, the College has decided not to offer M. Com in Business Management option to the learners due to less than adequate demand for this option. The I/c Principal further informed the Members that the College has already written about this to the University of Mumbai.

### d) MoU with the Indian Institute of Gems and Jewellery (IGJ)

The College has signed an MoU with the Indian Institute of Gems of Jewellery on June 13, 2023, to provide skill based vocational courses to the students of TCC which in turn will provide the students a career opportunity in the gems and jewellery industry through capability enhancement. The tenure of the MoU is for 3 years.

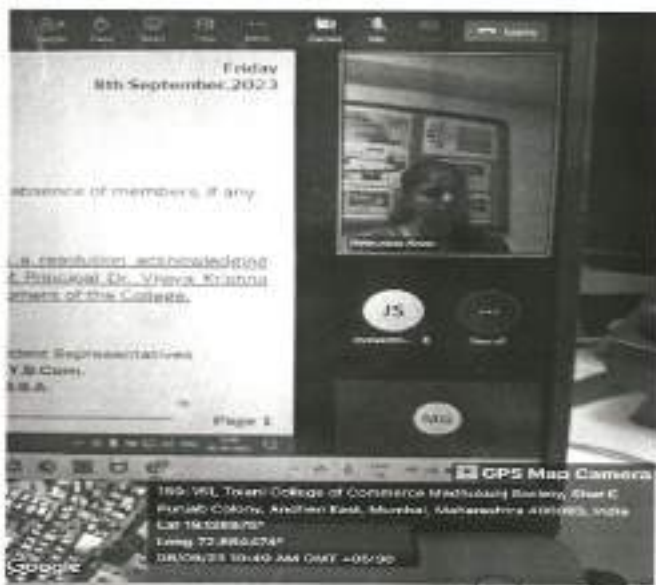
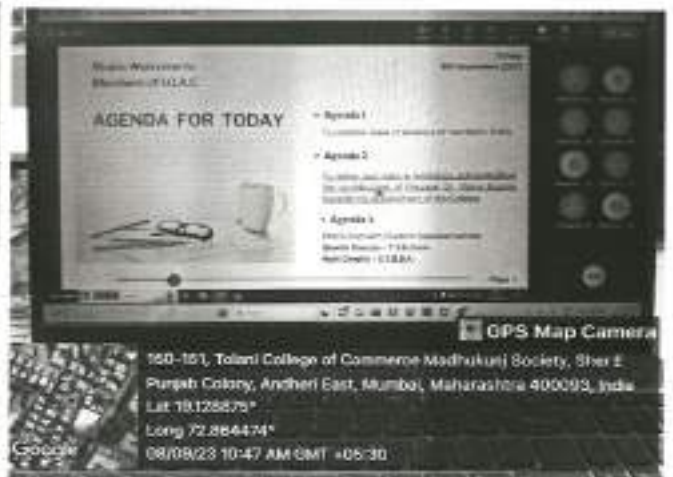

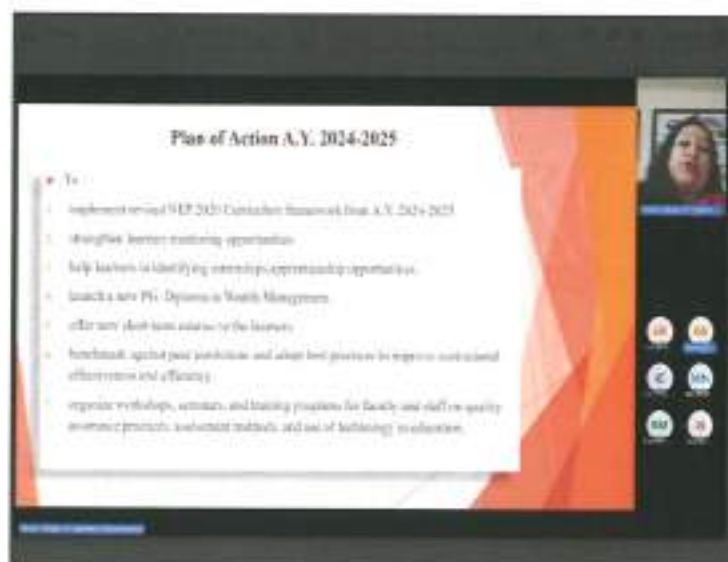
