## **ABOUT THE COURSE**

### **Higher Secondary Certificate (Commerce)**

**The Higher Secondary Certificate (HSC) is a two-year programme.**

After H.S.C. one may opt for a three year degree course leading to a general Bachelor of Commerce (B.Com.) degree or for specialised degree courses like Bachelor of Management Studies (B.M.S.), B.Com. (Accounting and Finance) and B.Com. (Banking and Insurance). All these courses are offered by the College.

### **Academic Subjects Taught (F.Y.J.C. and S.Y.J.C.)**

- 1) English
- 2) One of the following Subjects:

#### **Hindi / Marathi / French / Sindhi / Information Technology**

Seats in French are very limited and are given to students who have studied French at S.S.C. level or have scored exceptionally high marks in English and the total aggregate in S.S.C.

- 3) Economics
- 4) Book Keeping and Accountancy
- 5) Organisation of Commerce and Management
- 6) Mathematics or Secretarial Practice
- 7) Environmental Studies
- 8) Health & Physical Education.

The medium of instruction in all subjects, other than the optional languages, is English. N. B.: In the F.Y.J.C. Class the number of seats in Information Technology is 120. Information Technology subject is offered in only in combination with Mathematics subject in the un-aided section of our Junior college. In the Aided Divisions of the F.Y.J.C. Class, the number of seats in Mathematics is 240.

Seats in Mathematics are limited and are given on the basis of marks obtained in the subject at the SSC level. The cut off percentage in Mathematics is decided on the basis of the applications received in a particular year. Requests for changes in optional subjects must be given in writing to the Vice-Principal, within four days of the commencement of the first term. Application for change in optional subjects will not be accepted after the stipulated time period.

### **Remedial English Classes:**

Special English Classes are held for students who are weak in the subject at the beginning of each academic year. It is a well-structured course and 12 lectures are conducted. Emphasis is given on the improvement of spoken as well as written English.

The objective of this course is to improve the students' proficiency in English as all the main subjects in the commerce stream are taught through the English medium. A nominal fee is charged for this course. The lectures of Remedial English are held from 11.40 a.m. To 12.20 p.m. Attendance in these lectures is compulsory and the students who have enrolled themselves for the Remedial English course should not plan any other activity during the timings given.

## Admission Procedure

### F.Y.J.C.

Admissions for F.Y.J.C. are conducted online. The merit lists are prepared by M.K.C.L. (Maharashtra Knowledge Corporation Limited).

Students are required to take admission in the college allotted to them by M.K.C.L.

## **S.Y.J.C.**

### **Eligibility**

A student who has passed Standard XI from any recognised Board can seek admission to S.Y.J.C. Provided he/she fulfills all eligibility rules.

### **Documentation**

Originals of all the documents must be available for verification at the time of submission of the respective documents.

### **All students must submit**

1. Duly filled S.Y.J.C. admission forms (available at the College office).
2. Passport size photograph of the student with **white** background.

### **B. Students from other Colleges in Maharashtra (for admission in SYJC)**

4. No Objection Certificate signed by the Principal of the previous institution.
5. a. Students seeking admission under the Linguistic (Sindhi) Minority Quota are required to submit an affidavit on stamp paper of Rs.100/-, certified by a Notary stating that they belong to the Sindhi Minority community.  
b. Students seeking admission under any of the Reserved Categories are required to submit an attested copy of the relevant certificate/document.

### **C. Students from Boards other than the Maharashtra Board (CBSE/ICSE,IB, etc.)**

1. Two attested copies of Standard Xth mark sheet.
2. Two attested copies of Standard XIth mark sheet.
3. Original School/College Leaving Certificate / Transfer certificate (with counter signature by appropriate educational authority), with two attested copies.

4. a. Students seeking admission under the Linguistic (Sindhi) Minority Quota are required to submit an affidavit on stamp paper of Rs.100/-, certified by a Notary stating that they belong to the Sindhi Minority Community.
- b. Students seeking admission under any of the Reserved Categories are required to submit an attested copy of the relevant certificate/ document.
5. Application for provisional eligibility certificate (prescribed form available at the College).
6. Original Passing Certificate issued by the relevant Board with two attested copies.
7. Deed of undertaking on stamp paper of Rs.100/- (format available in the eligibility form).
8. Migration Certificate (in case there is no practice of issuing migration certificate by the Board, the candidate shall produce a letter to that effect from the Board).
9. Foreign students have to submit a duly filled 'Appendix A' form (available at the College).

### Attendance

Attendance of students is drawn to Regulation No.88, of the Maharashtra State Board of Secondary and Higher Secondary Education Board Regulation, 1977, according to which students are required to have minimum 75% attendance in each term failing which, they will not be allowed to appear for the Higher Secondary Examination (Std. XII) or the F.Y.J.C. (Std. XI) Annual Examination.

Parents are requested to take special notice of the mandatory condition of minimum attendance of their ward. Application for leave on account of bonafide illness or other reasons should be submitted to the college office (inward section), for condonation of absence. The decision of the Principal shall be final and binding in such matters.

If a student remains absent without prior permission for a long time, his / her name will be removed from the college roll. The college is not required to send any intimation regarding the same to the student or to the parents / guardians concerned. S.Y.J.C. Admissions will take place in the first week of May. Students are requested not to plan their vacation during this period.

A student will not be allowed to appear for any examination if the college dues have not been paid. Attendance in all the examinations: written and Oral/ABT/Practical is compulsory.

The final results of the student is decided on the average of the marks obtained in a, b and c.
